DISTRICT REPRESENTATIVES NEWSLETTER

November, 1952

Your District Representatives have voted to resume publication of a Pimmit Hills Newsletter to keep residents of Pimmit Hills up-to-date on community affairs. We hope that this newsletter will be distributed around the middle of each month. Our goal is to let residents know what the Citizens Association is doing, and the background of some of the topics that will be discussed at the next meeting.

JOBS WELL-DONE DEPT: Thanks to the efforts of Pat Healy and his Roads Committee, Pimmit Drive and Cherri Drive have been resurfaced.

Street signs have now been erected throughout Pimmit Hills by Mr. Offut of the O. & R. Construction Co. who offered to purchase and install the signs following a meeting with the Executive Committee of the Association.

The School Committee, headed by Mrs. Ruthollyn McCormick, has recently completed a survey of Pimmit Hills to determine the number of present and future school children. Result: In 473 occupied houses (all in the old section) a total of 770 children through age 16 were counted!

THE SCHOOL SITUATION GROWS BRIGHTER - - Mr. Woodson, Superintendent of Schools in Fairfax County, has invited Mrs. McCormick, chairman of the School Committee, and officers of local PTA groups to meet with him on November 19 to discuss the school problems facing residents of Pimmit Hills next year. Incidentally, 5,000 residents of Fairfax County, including two-thirds of the registered voters from Pimmit Hills signed the petition requesting a school bond referendum to finance new schools. The vote will probably be held in January.

WE GOT OUT THE VOTE - - We now have 279 registered voters in Pimmit Hills. The Citizenship and Public Affairs Committee headed by Mrs. Claude Lehman deserves credit for this fine record.

IN THE WORKS: Maggie Gresham, chairman of the Social and Recreation Committee announces that a Community Dance has been planned for December 13. It will be held at the McLean Firehouse beginning at 9 p.m. Better line up your baby sitter today! Tickets are \$2.50 a couple. Incidentally, Maggie still needs volunteers to sell tickets on Pimmit Drive from Leesburg Pike to Paxton Road, Anderson Road and Cherri Drive and also in the new section.

LONG LIVE PIMMIT HILL-ers, WE HOPE! The Association has requested the State Highway Department to take immediate steps to reduce the traffic hazard at the intersection of Lisle Avenue and Leesburg Pike. While they're at it, we hope they'll do something about the Pimmit Drive intersection too.

ANOTHER BATH A WEEK ? - Water and Sewer rates for Pimmit Hills are being studied by the State Corporation Commission. Bob Dunne on Cherri Drive started the ball rolling by asking the Commission to review the present rates of the Pimmit Service Corporation. Officers of the Association have asked the Commission to keep them informed of developments. Let's hope the investigation will mean lower and not higher rates.

A CONTEST - - Prizes will be given for the most attractive exterior Christmas decorations in Pimmit Hills. The Housing and Gardening Committee, headed by June Henry, will make the awards. It's not too early to begin planning right now for your display.

HIGHER EDUCATION DEPT.: Those at the Armistice Day Citizens Association meeting can tell you what an excellent talk Mrs. Louise Palmer of Annandale gave on the proposed magisterial re-districting of Fairfax County. Far from a dull subject, the audience sat glued to their chairs during her explanations, and asked many questions when she finished. It can't be stressed enough how important this event is to our future here in Pimmit Hills. With our anticipated population, it is not at all beyond the realm of possibility that a school board member or even a County Supervisor might come from our ranks.
